# **Chelmarsh Parish Council**

The Annual Parish Council meeting was held in Chelmarsh Parish Hall on Tuesday 20<sup>th</sup> May 2025 at 7.30pm.

All elected Cllrs signed their Declaration of Acceptance of Office.

Newly elected Shropshire George Holyhead attended the meeting and introduced himself to the Councillors and Chairman asked all Cllrs were asked to introduce themselves.

#### 1) Election of Officers:

- a) Chairman: Cllr Woods asked if he was prepared to carry on, which he was, so it was proposed, seconded and **RESOLVED that Cllr Woods is Chairman.**
- b) Acceptance of Office by Chairman signed
- c) Election of Vice-Chairman Cllr Thomas did not wish to be nominated. Proposed, seconded and **RESOLVED** to elect Cllr T Cole as Vice-Chair.
- d) Acceptance of Office by Vice-Chairman signed
- e)SALC Area representatives Cllrs Cole and Cadwallader agreed to be the representatives.

#### 6) Matters arising from minutes:

Clerks report:

Road closures:

Signage has once again left a lot to be desired with many complaints received.

The clerk had a message yesterday for confirmation that there would be no road closures for 22<sup>nd</sup> May due to a funeral. This was the reply after I mentioned the road closure at Eardington: Thank you for highlighting this issue with us.

I can confirm that STW were meant to be here under lights as the Highways closure was lifted on Friday. We have sent an inspector to site to clarify this and it appeared they have closed the

road without our knowledge. I can confirm the road is open and they should be clear off site tomorrow.

There was a discussion regarding the confusing signs, start/finishing times/some potholes not filled and the need to come back and close the road again at the end of the month to complete the work.

Clerk understood that this was due to workmen not being able to use the required machine at the same time as others were being used. Hopefully the work will all be completed at the end of the month.

S. Cllr Holyhead will raise the concerns with SC and Clerk will write.

# 7) Planning applications/refusals:

# 9) Finance:

a) Clerk's salary - £xx paid standing order. HMRC- £ 147.83Insurance renewal - ££423.38 (last year £421.91) and this is the last year od the Long-Term Agreement. Clerk had obtained quotes from other insurers which were far more expensive.

We have PL on playing field, cricket pitch and car park but we do need to carry out regular risk assessments. Cllr Thomas was happy to do this and Cllr Strong confirmed that the Cricket Club do their own anyway.

b) Any others received after issue of agenda:

SC – STREETLIGHTING – £164.02 (last year £162.44). Clerk has sent in new inventory to SC of the streetlights, as requested.

**RESOLVED** to pay all accounts.

EMG \_ Lengthsman Scheme: Clerk requested confirmation that the amount to send to SC was £750. It was **RESOLVED to send in account for this amount, but the PC would not be going ahead with the scheme for 2025/26**.

Richard Millington had contacted the Clerk regarding the Hampton Loade junction needed cutting, but Clerk has already asked SC to add this to their schedule.

c)To confirm Asset Register – sent out separately. Cllr Woods queried if the bench at The Yeomans should be included – Clerk will check this and add if needed. All **RESOLVED to accept the Asset Register with this alteration, if needed.** 

d) Standing Orders and Financial Regulation Policies:

Agreed to approve the Standing Orders. Financial Regulations need altering.

#### 10) Parish problems:

- ✓ Bus from Bridgnorth/Highley is not stopping to pick up and drop off at Sutton. The PC had been in touch regarding this previously as there is a bus timetable at the end of Covert Lane. Clerk was asked to write to Diamond Coaches.
- ✓ Noticeboard unable to be opened to change posters at Hampton Loade. SVR kindly took this noticeboard away and put grandfather posts to fix it. Clerk had emailed to say thanks.
- ✓ Unicorn Inn had queried if the PC would donate towards replacing the defibrillator. They will be getting a quote from Dave Fulton and when the costs are available, the PC will donate.
- ✓ Defibrillator check of the machines at The Buls Head and the Sports & Social Club need doing. Cllrs Thomas and Strong offered to do this. Clerk will send instructions.
- $\checkmark$  Gully dug out along Ingram Lane, but water now runs into the field.
- ✓ Clerk had received a complaint regarding a chain being put across the parking area opposite Astbury Terrace, which is causing problems for passing vehicles and cannot be see at night. Clerk was asked to report this via FMS.

### a) Police:

Reply from PC Nolan regarding traffic concerns raised last month:

The accident outside the church was a minor bump (I attended), I will certainly help in whatever you need me to, I noticed the mirror could do with a clean. Speeding vehicles are a problem especially now the summer months are here; I will be utilising the motorbike speed enforcement teams now hopefully this will help. If any of the overtaking and road rage incidents are caught on dash camera I can deal with these if the offences are captured, do you know if they reported this to the police?

In terms of the rural crime, Shropshire is so vast, and our resources so stretched it is a nightmare trying to cover all the rural areas with a 24 hour period, Myself and my 2 CSO colleagues are actively patrolling all our parish areas as much as we can whenever we are on duty, And I know that our response colleagues are also patrolling where they can, I will speak with the officers allocated these crimes and see if they have any leads or suspects and assist where I can
