Clerk had checked this with SC, and it was not a planning application, and details were given by SC Licensing.

Cllrs felt that The Astbury should make better efforts to let locals know when events, especially when fireworks are involved, due to the number of livestock, horses, does etc who get spooked. S Cllr Hollyhead will take this up with The Astbury and Clerk will make this comment to SC Licensing.

c) Any received after issue of agenda - none

- a) Shropshire Councillor's report. Cllr Hollyhead confirmed that the old Local Plan is out, and a new one is in the process. There s a call out for land to limit the impact on the green belt and SC are asking landowners to come forward with proposals for consideration.
- b) Police no report, but a survey had come through this afternoon. Chairman pointed out that he had recently completed one and asked Cllrs to complete this.
- c) Parish Hall Meeting this Thursday evening, the show went ahead, although numbers appeared to be down (very hot day).

Lease with the Church is progressing.

Secretary sent email requesting invoice for the grass cutting, but we do not get this until November. Chairman confirmed that the committee had suggested a 50% donation towards the £350 quoted. The Parish Hall will need an invoice from the PC.

Clerk understood that all Cllrs should have a .gov.uk email address but Chairman asked Clerk to seek clarification as if this was mandatory then this was very expensive for small parish councils and needs taking further by SALC.

- Unicorn Inn donation towards defib. As the PC provided the ones at the Sports &
 Social Club and Bulls Head, they felt this one should be purchased completely. Clerk
 will contact the Unicorn as it will need to be ordered in the PC name in order to reclaim
 the VAT.

RESOLVED to pay all accounts.

- b) Quarterly Bank Reconciliation emailed separately. Clerk talked Cllrs through these and it was **RESOLVED to accept these.**

8) Parish problems:

Problems raised by Cllrs.

- Clerk pointed out that speeding had been mentioned on Facebook and that Police ought to come early morning or 4-5pm. It is now school holidays, so traffic does appear to be less.
- Clerk has tried to contact Alan Walker again regarding the Sutton sign but no luck.
- Double hedges need dealing with between Sutton, along Ingram Lane and into Highley.
 Two large vehicles have difficulty in passing and residents visibility from drives are impaired.
- Grass verge/pavement not cut/cleared on Sutton bend only verge cut. This does belong to SC.
- Any others:
 - Email received from Sports & Social Club requesting permission to put sign on the 'pallet board' at the junction of School Lane. Clerk had been asked previously if planning permission was required and had given the details to the Secretary. It appears that as the 'pallet' has been there continuously for 10 years permission was not required. After discussions Clerk was asked to reply as follows:
- ✓ There is already a directional brown sign opposite School Lane pointing to the Sports & Social and Bowling Club.
- ✓ Sign should say 'Members Only'.
- ✓ The sign would be better sited on the gate into the Sports and Social Club not on the roadside.
- ✓ Why do you need to advertise the opening hours as members should be aware of these.
- ✓ The sign stating room hire, functions, parties is felt to conflict with the Parish Hall.
- ✓ The pallet has been used to advertise many local events, i.e. rummage sales, fete etc and Cllrs have no objections to the Sports & Social Club using this to advertise events, but the pallet is not for their exclusive use.
- ✓ It appears that the pallet is on Shropshire Council land not land owned by the PC.

Cllrs feel that if you are not happy with this decision then please feel free to submit a planning application to Shropshire Council as the Parish Council are only consultees and have no power to grant such permission.
